John Troughton moved to approve the minutes of the April 15, 2019 regular meeting. Motion was 2nd by Mike Charter. **Motion passed. The Financial Reports as of 5/16/19 and the 4/13/19 – 5/16/19 Check Registers were presented and discussed. Mike Charter moved to accept the financial reports and approve Checks # 14292 – 14356 out of Umpqua Bank Checking xxx1215 totaling \$66,886.64, Checks # 178 – 179 out of Umpqua Bank Impact Fee Fund xxx1223 totaling \$276,300.10 and Check # 1007 out of Umpqua Bank Capital Equipment Replacement Fund xxx6829 totaling \$126,300.10. Mike Charter moved to commit the 2018 Strike Team/Contract Fire Net Reimbursements of \$143,016.63 to the Umpqua Bank Capital Equipment Replacement Fund. Motion was 2nd by Robert Mendoza. Mike Charter moved to approve the final revised 18/19 Capital Budget of \$393,359.89. Motion was 2nd by Sam Reynolds. **Motion passed. Chief's Report:

- The April 2019 Stats were presented.
- Reported on incident with Rescue 3061. Approximate \$5400 in damage.
- Reported that Engine 3011 has had major issues with controllability. Has been worked on 5 different times. Chief had a Cal Fire off duty mechanic drive it and that individual stated that it needed to be placed out of service. Chief has requested that Ferrara Fire send an engineer to drive it. He was informed that Ferrara Fire will have the truck transported to their facility in Louisiana. Chief stated that the warranty is suppose to compensate for out of service time.
- Reminded board members to read their Long-Term documents.
- Reported that a meeting is scheduled on 5/22/19 for the Colusa County Fire Chiefs to meet with SSV EMS to discuss ambulance and hospital issues.
- Reported on status of Fire Assistance Agreement issues. Stated that it has made the national news.

John Troughton moved to adopt Resolution No. 19-02, A Resolution of Intention to Continue Assessments for Fiscal Year 2019-20, Preliminarily Approving Engineer's Report, and Providing for Notice of Hearing for the Williams Fire Protection Authority Fire Suppression and Services Assessment. Mike Charter moved to adopt Policy 19-02 – Strike Team Payroll Fund. Motion was 2nd by John Troughton. Motion passed. Ayes <u>5</u> Noes <u>0</u> Absent <u>1</u> by the following vote: Charter – aye, Gobel – aye, Mendoza – aye, Alternate Reynolds – aye, Troughton – aye, Turner - absent.

Board members received a letter from Golden State Risk Management Authority (GSRMA), informing that the Williams Fire Protection Authority (WFPA) was elected to have a WFPA board member serve on the GSRMA board of directors. John Troughton had previously stated that he would be willing to serve on behalf of the WFPA on the GSRMA board. Mike Charter moved to nominate John Troughton to serve as WFPA representative on the GSRMA Board of Directors. Motion was 2nd by Robert Mendoza. **Motion passed.
