- Reported that the SCBA's being purchased as part of the FEMA Regional Grant Project with Arbuckle and Colusa Fire have arrived and will be placed in service soon. He stated that the Authority was receiving approximately \$11,200 for trading in old SCBA's.
- Briefed on recent fit testing held.
- Reported that the Authority has an engine on the Camp Fire in Butte County. The engine should be released within the next day or two.
- Reported that Chief Cohen of Maxwell Fire got approval for his EMT's to be EMT ALT's. Chief Gilbert is going to inquire if the departments EMT's are interested. It would require 180 hours of additional training. All departments are looking into it as a result of less ambulance coverage in the county.
