Kara Alvernaz asked that the Umpqua Bank Capital Equipment Replacement Fund be uncommitted to cover 2020 Mutual Aid expense and payroll costs. Doug Turner moved to uncommit up to \$200,000 from the Umpqua Bank Capital Equipment Replacement Fund to be used as needed to pay 2020 Mutual Aid expenses and payroll costs until reimbursements are received from the State of California. Motion was 2nd by Esteban Torres. **Motion passed. Ayes 5**Noes 0 Absent 0 by the following vote: Gobel – aye, Mendoza – aye, Torres – aye, Troughton – aye, Turner – aye.
